**Election of GPC regional representatives 2018-2021 - UK**

**Nominations are now open**

Nominations are sought in the election of voting members of the GPC of the British Medical Association as regional representatives for the constituencies detailed below.

- Norfolk, Suffolk, Great Yarmouth and Waveney.
- Enfield and Haringey, Camden and Islington, Barnet, Kensington and Chelsea, and Westminster.
- Merton, Sutton and Wandsworth, Kingston and Richmond.
- Sefton, Liverpool, and Wirral.
- Salford and Trafford, Manchester, and Stockport.
- Durham, and Cleveland.
- Grampian, Highland, Orkney, Shetland, and Western Isles.



- Forth Valley, Fife, Lothian, and Tayside.
- Somerset, North and East Devon.
- East Sussex and West Sussex.
- Derby and Nottinghamshire.
- Gwent, Bro Taf, and Morgannwg.
- Herefordshire, Worcestershire, Warwickshire, and Coventry.
- Birmingham and Solihull.

**Candidates must be one of the following:**

- A GP who provides personally, or performs NHS primary medical services for a minimum of 52 sessions distributed evenly over six months in the year immediately before election, and has contributed to the voluntary levy of an LMC, thereby supporting the work of the GPC on behalf of all GPs.
- A GP on the doctors retainer scheme and has contributed to the voluntary levy of an LMC in the constituency (the LMC must then contribute the voluntary levy to the GPDF).
- A medically qualified LMC secretary.

Each nomination form must be signed by the candidate and a representative of the LMC who can confirm that the candidate and proposers contribute to the voluntary levy.
